

I also agree to accept all financial conditions and agreements.

I understand that NTI's programs are not designed to meet any specific state, provincial or national licensing laws. It is my responsibility to investigate the licensing procedures where I will be practising. I understand that I can start my studies anytime for the Distance Education, Tele-learnings and Apprenticeship components and that the intensive Residencies will be scheduled according to the number of students registered. The CASC Certificate Program is equivalent to two year of studies; the Diploma Programs to two to four additional years of studies depending on my goals, background and the amount of time I commit to my studies. Since I am proceeding with my studies at my own rate, I may complete my studies in a shorter or longer period of time. I have read through the Course Catalogue and fully understand the detailed outline of course content; description of methods (Distance Education, Tele-learnings, Apprenticeship and Intensive Residencies that include experiential learning as well as written and experiential examinations). In addition, my work will be mentored through my practicum and internships. I understand that I must also complete 300 hours of personal development workshops or programs - half of which, when possible, should be through an Interfaith Centre or NTI. I have read and understand the course fees and the book fees. I have the option of paying in advance by each Module or by each Program in total. The fees for each of the modules and the five programs are outlined fully in the *RAP (Record of Acceptance/Progress – Summary of NTI Programs)* form in the Catalogue. These fees are, without notice, subject to change of those communicated in the most recent publication of the Course Catalogue. The intensive Residencies must be paid in advance. **I understand that NTI is the official seminary for OIIM, the Open International Interfaith Ministry®, and as such, I need to be an OIIM Member and Registrant (annual fee \$70 due January 1 of each calendar year) to participate in its seminary program and to work within OIIM's structure.** The OIIM Registration Board will accept NTI graduates and awards the following credentials: *RSl, CASC, RSPH, RSPc, RSPm, RSPd, LM and OM* in the following Registered levels: *Student, Candidate, Initiate, Apprentice, Practitioner, Minister and/or Master*. Course work must be completed within 7 years of acceptance with at least 6 credit hours of Distance Education assignments completed each year. A formal leave of absence extending these requirements may be formally requested in writing to the Registrar. Once the required time of completion is up, the student loses the Loyalty Plan perks and must start all course work, including Apprenticeship, Tele-learning and Residency from the beginning.
